Assurance for consultation on starting allocations for the Brownhill Cable Joint Refurbishment BBI

1. Transpower intends to consult stakeholders on the proposed starting benefit-based investment (**BBI**) customer allocations (**starting allocations**) for the Brownhill Cable Joint Refurbishment BBI, which the transmission pricing methodology (**TPM**) requires that Transpower treat as a separate post-2019 BBI under the TPM.
2. The TPM requires Transpower to publicly consult on proposed starting allocations for post-2019 BBIs expected to be “high-value”,¹ including any material departures from Transpower’s benefit-based charge assumptions book (**assumptions book**).² The Brownhill Cable Joint Refurbishment BBI is expected to be high-value.

Scope of our review

3. Transpower asked Simpson Grierison to provide assurance in relation to the consultation paper and draft record relating to the starting allocations for the Brownhill Cable Joint Refurbishment BBI (**consultation documents**), specifically whether the consultation documents comply with the TPM and are consistent with aspects of the assumptions book.

Assurance

4. In our opinion, and subject to the qualifications and limitations noted below:
 - (a) the consultation documents comply with the TPM in all material respects; and
 - (b) the processes and methodologies applied in the consultation documents are consistent with those set out in the assumptions book, except where stated

¹ A post-2019 BBI is high-value if the sum of its capex and opex is more than the base capex threshold under the Transpower Capital Expenditure Input Methodology (\$30m).

² The version of the assumptions book we have referred to for assurance is version 3.0 from June 2026. This is the most recent version of the assumptions book.

otherwise in the draft record. The reasons for any material departures from the assumptions book are explained in the consultation documents.

Qualifications and limitations

5. Our assurance in paragraph 4 is subject to the following:
- (a) Our assurance is based on the information made available to us by Transpower.
 - (b) As instructed, we have not reviewed the appendices to the draft record.
 - (c) Our assurance addresses legal requirements and legal form. We do not express any opinion on the technical, economic, engineering or modelling aspects of the consultation documents, as those aspects are outside our role and expertise.

Except to the extent (if any) required by law, no other person may, without our written consent, use this letter, either directly or indirectly, or enable this letter to be relied upon by any other person, or allow this letter to be quoted or referred to in any document, whether public or private, or filed with any regulatory authority.
7. We are aware that Transpower intends to disclose this letter with the consultation documents. We understand the disclosure of this letter is not intended to waive privilege in any advice we have given to Transpower in relation to the consultation documents or any other matter.
